



HASS Profiling ~ Clare Dyson

Clare Dyson is an artist and scholar who creates collaborative dance, theatre and site specific performances in Australia, Europe and America. She has published research on dance, written a reference book on Australian dance, presented at conferences and recently completed her PhD on audience engagement. She was a member of the New Media Arts Fund of the Australia Council as a policy maker and advocate for dance. Her film works have been screened nationally and internationally and she has been the Artist-In-Resident at the Judith Wright Centre and the Powerhouse in Brisbane, at Tanzfabrik in Berlin, Djerassi in the US and Cite des Arts in Paris.



After nearly two decades working as a choreographer, she successfully opened the doors of Room 60, a new licensed venue in Brisbane to the public last year. Here, she talks about the successful marriage between art and entrepreneurship:

"As an artist, all the art I have made is about engaging with the audience; my PhD was on audiences connecting with art. So I feel that running my business is just an extension of the artist in me," she says.

Reflecting on her decision to set up *Room 60*, Clare remarks, "Australians tend to socialize in places where they can get a drink. I wanted to open a licensed place where one could merge the creative with the academic, and also support the generation of new ideas. So *Room 60* was born - a cultural space and bar that allows one to experience the unusual."

Room 60 is an intimate space that hosts artist performances, live music sessions, art openings and philosophy discussions. "Universities are often lacking social spaces where you can be creative and still be intellectual; creativity strikes when you are least expecting it. As an artist, I would often brainstorm in a pub, so this was an obvious choice. Set in the University suburb of Kelvin Grove, Room 60 is an interesting space in an academic environment and has been very well accepted," she adds.

Clare believes her background as an artist really helped shape her business sense. "To be a really good artist, you have to be a really good business person. Whether I'm creating an art work or making a cocktail, I try to make it new, original and beautiful. In difficult times, my artistic background has helped me to overcome challenges. As an artist, you have to fight all the time because everything is so difficult, maybe lot more difficult than running a company! So I think I've been well prepared."

"Having said that, I truly believe that there are lot of business people out there who know a lot more about my particular business. I have made a lot of mistakes which other business people may have avoided. But I do think there are a lot of generic things in the market. Being an artist, my edge is creating something unusual. My customers come for a different experience and appreciate when they get that," she adds.

"People are still discovering us – I have patrons come up to me and thank me for creating an unusual space that allows them to experience something unique. It's hard and quite a struggle, but I'm quite proud of it", she concludes.

Australian National Maritime Museum: Nawi - Exploring Australia's indigenous watercraft

This first major conference on the watercraft of Aboriginal and Torres Strait Islander peoples, seeks to bring together practitioners and theorists from a range of institutions, groups, communities and individuals interested in the history, conservation, construction, interpretation and presentation of Australia's indigenous watercraft from 30 May - 1 June 2012. Demonstrations and talks by traditional canoe builders and people engaged in reviving traditional canoe building practices and knowledge will be a highlight.

National Gallery of Australia - 'unDisclosed' ~ 2nd National Indigenous Art Triennial

From 11 May - 22 July 2012, the National Gallery will celebrate the second National Indigenous Art Triennial 'unDisclosed', a dynamic visual expression of contemporary Aboriginal and Torres Strait Islander art. From across the country, 20 Aboriginal and Torres Strait Islander artists have been selected to represent Indigenous arts today. The exhibition's theme, 'unDisclosed', alludes to the spoken and the unspoken, the known and the unknown, what can be revealed and what cannot.

<u>Australian Institute of Aboriginal and Torres Strait Islander Studies - Annual National Native Title Conference</u>

The Annual National Native Title Conference 2012 will be convened by AIATSIS and North Queensland Land Council (NQLC) on the traditional lands of the Wulgurakaba and Bindal Peoples, traditional owners of the wider Townsville area in Townsville from 4 - 6 June 2012. The Conference is an opportunity for people to come together and engage in debate, including native title holders and claimants, traditional owners, native title representative bodies and service agencies, the Federal

Court, National Native Title Tribunal, Commonwealth and State government agencies, academics, consultants and industry representatives.

Ausdance - Australian Dance Week 2012

The Ausdance network celebrates and promotes dance in all its forms every year during Australian Dance Week in May. Each state and Territory hosts a variety of events and encourages its dance community to promote their own activities throughout the week.
